Financial Chapter Support is provided to our local chapters to plan and host educational presentations, field trips and events. Educational publications include a bimonthly newsletter, The Sabal Minor, a quarterly magazine, The Palmetto, as well as videos and interactive content on social media channels.

Funding for students and conservation professionals is made available through grant programs supporting research, applied plant conservation, and ethnobotany.
